MOTION FOR EXTENSION OF TIME

COME NOW Claimants Annie Farmer, Maria Farmer, Teresa Helm, Juliette Bryant and Jane Doe 1000 (hereinafter "Epstein's Victims"), by and through their undersigned attorneys, Kevin F. D'Amour, P.C., and motion this Court to extend the deadline to file a brief on the issue of the Estate of Jeffery E. Epstein's ability to establish and fund a voluntary claims program given the liens filed against the Estate by the Government of the Virgin Islands ("GVI"). Counsel for Epstein's Victims need additional time to engage in discussions with the GVI about coming to a resolution regarding the concerns that the GVI has raised, and seek this extension during the pendency of those discussions. Epstein's Victims request an extension of the current deadline for filing a brief on that issue to fifteen (15) days after the conclusion of the discussions with GVI. A draft order is provided.
